General Objectives: training Teachers ability to raise awareness and advice students on data protection issues

***The Training Activities focused on elementary and secondary teachers

***Greek language was used (training activities – educational material)

1. Introductory awareness raising event



Objective - communicating the byDefault project

- providing basic introduction on data protection issues
- reflecting the views of participating teachers

Preparation: 4.10.2023 a three-hour in-person introductory training session was held at the University of Piraeus

Invitation: -Open call to teachers (28/9/2023 invitation email)

- -place: Conference Room of the University of Piraeus
- -Regional Educational Planning Centers and Directorates of Primary and Secondary Education in Greece
- -Subscription through EU Survey link
- -Certificate of Attendance

Design: -fundamental principles and concepts of personal data protection

-discussion regarding specific risk scenarios

Participants allocation: 30 teachers





2. Preparatory fast-track training webinar



Objective -preparation of teachers to support the program

- -familiarizing participant teachers with the basic principles of data protection
- demonstrating the educational game 'TZIMANIOUS' to play it in the classroom

Preparation 15.02.2024 a four-hour distant learning teachers' training seminar

Invitation -invitation was sent to interested teachers (12.2.2024)

- -teachers had to confirm participation and complete the attached form with necessary information
- -information about *Certificate of Attendance*

Design –basic principles presentation and specific scenarios discussion

-'TZIMANIOUS' presentation ***developed by HDPA and University of Piraeus

Participants allocation <u>17 teachers</u> from 9 elementary & secondary schools



3. *Extended* learning and training seminar



Objective training & sensitizing teachers by offering theoretical and practical knowledge

(principles / basic concepts, risks of using internet, best practices to manage these risks, rights of data subjects)

Preparation An extended 50-hour (8 weeks) DISTANT training seminar for elementary and secondary education

teachers, entitled 'Protection of Personal Data' offered by the Education and Lifelong Learning


Center (KEDIVIM) of the University of Piraeus took place (4/4-6/6)

Invitation Open call (13/3/2024 email) -Regional Educational Planning Centers

- -Directorates of Primary and Secondary Education of the Ministry of Education
- -Subscription through EU Survey link
- -Certificate of successful completion

Design -distant learning – training seminar

- -synchronous / asynchronous training
- -educational and instructional material (online teacher training platform)***
- -8 consecutive sections / 1 per week /~3 hours presentation (~ ½ hour discussion)
- -each topic was presented by a specialized scientist of HDPA
- platform forum for discussion



Participants allocation 100 (regional - geographical coverage) /successful completion 🗟



Educational and instructional material (online teacher training platform)***



- ✓ Webinars [PowerPoint (ppt) presentations and recorded videos of the webinars presented by a specialized scientist of the HDPA]
- ✓ Breakout sessions [participants were divided in digital rooms in groups of ten, in order to discuss questions on practical scenarios, which were then presented, explained and analyzed by the specialized scientist. The practical scenarios were available in the training platform and the relevant link was readily available to the participating teachers via the chat option]
- ✓ Optional and mandatory quizzes and/or questions with a true or false option as well as optional practical scenarios for further study [For the better understanding of the educational material by the participants]
- ✓ Explanatory notes and optional additional educational material.



4. Conclusive fast-track training webinar



Objective -educating and raising awareness among teachers on basic issues

-familiarizing teachers with 'TZIMANIOUS'

Preparation 18/6/2024 a four-hour distant learning teachers' training seminar

Invitation -invitation sent by email

-subscription through EU Survey link

-certificate of attendance

Design -explanation of principles & basic concepts of personal data protection

- -risks of using the internet
- -best practices to manage these risks
- -protection based on rights of data subject

Participants allocation 65 [19 from Primary school and 46 from Secondary school (middle and high school)]

***After the completion of this webinar, an email was sent to the attending teachers on the 19/06/2024 in order to complete an evaluation form, which was made available through a questionnaire using the EUSurvey tool
